Respected Officials/ Bonafide Members,

As we are aware, that NCAHPAct-2021 has been implemented. During their addresses on October 21, 2024, at Jawaharlal Auditorium, AIIMS, New Delhi, the Chairperson and Secretary of NCAHP, comprehensively outlined all aspects of the National Commission. On the same occasion, the Honourable Prime Minister of India, Shri Narendra Modi, has launched the Allied and Healthcare Professionals Enrolment Portal on October 29, 2024.

In various meetings and correspondence between the Ministry and Commission, our association has consistently emphasized that 50% of the total 56 cadres would comprise of laboratory technologists. Therefore, it is our responsibility to enrol on the **AHP portal** (<u>ahpr.abdm.gov.in.</u>) as soon as possible, ensuring our database is readily prepared for the government. Our participation will be reflected in the National Commission and Council.

We urge you to treat this matter of utmost important and do the needful at the earliest.
