- Hold at least BSc. in the relevant field with at least 10 years of distinct experience in the field of medical laboratory technology, MSc. in the relevant field with at least 05 years of sole experience in the field of medical laboratory technology, an M.Sc. in Medical Laboratory Technology (MLT) and a Ph.D. from a UGC-recognized University (with significant contributions to scientific research in fields such as Pathology, Microbiology, Biochemistry, Blood Transfusion, Molecular Genetics) would be preferred.
- Proven experience in education, curriculum development or research.
- Active AIMLTA members with expertise in Medical Laboratory Technology, clinical sciences, or academia.
- **Post-PhD. experience** in teaching or research in the specialized subject area, with at least one year as Scientist Grade.

- Over **Five years of postgraduate's experience** in teaching or research the in specialized subject area related to MLT, with at least FIVE years as an Assistant Professor or Scientist Grade.
- Demonstrated record of scholarly or professional activity, including peer-reviewed research publications that advances the knowledge and scholarly competence.
- At least **five refereed journal publications** in Scopus or Web of Science-indexed journals, with at least **five of these in SSCI or SCIE Impact Factor journals** from the Clarivate Analytics Database.
