**Dear Respected Medical Laboratory Professionals across India,**

We're writing to bring to your attention a crucial matter concerning the betterment of lab technologists nationwide. As you're aware, the NCAHP Act-2021 has been implemented, and the National Commission's Chairperson and Secretary outlined its aspects on **October 21, 2024**, at **Jawahar Lal Auditorium, AIIMS, New Delhi**, on the occasion of our **43rd All India Conference & Scientific Seminar, "LABTECHCON-2024"**. Notably, the Honourable Prime Minister, Shri Narendra Modi, launched the Allied and Healthcare Professionals Enrolment Portal on October 29, 2024.

In our interactions with the Ministry and Commission, we've stressed that majority of the 56 cadres would comprise of laboratory technologists. Therefore, it is our responsibility to enrol on the **AHP portal ([ahpr.abdm.gov.in](http://ahpr.abdm.gov.in))** as soon as possible, ensuring our database is readily prepared for the government. This participation will be reflected in the National Commission and Council.
