# RULES FOR THE ELECTION

## 1. GENERAL

- 1(a) All bonafide members of the Association whose names are included in the AIMLTA U.P. State Provincial list for year ending 2023 are eligible to contest, propose and second the nomination for any of the posts, mentioned in the Election Notice. The contestants must be a bonafide member / life member and well acquainted and have sound knowledge of the working of the Association.
- 1(b) The bonafide representative member of the Association, whose name are included in the AIMLTA U.P. State provincial list for the year 2023 on the basis of precedence 1:10 as per Memo No.AIMLTA/GS/303/2023 dt. 10/08/2023, will be eligible to cast vote at the time of election.
- 1(c) The election for all post, where pooling is necessary, will be held directly by a secret ballot.
- 1(d) Once the State Election Officer has been appointed, the SEC will have no right to interfere or influence the State Election Officer till the elections are over and result are declared.
- 1(e) State Election Officer may report the SEC about the number of nominations received post wise ( valid / invalid ).

## 2. ELECTION

- 2(a) The State Office bearers will be elected as per Articles19(D)(E). The State Executive Members (area wise), have been bypassed from election, to shorten the election procedure. Selection of these will be done by elected state committee and other worthy and appropriate dignitaries.

## 3. FILING /WITHDRAWAL OF NOMINATIONS

- 3(a) Bonafied regular members, desiring to contest election must submit their Nominations, separately for each post in the prescribed nomination form (specimen copy enclosed ) DULY COMPLETED WITH ALL REQUIRED INFORMATION, LEAVING NOTHING BLANK and send to the State Election Officer at the address specified. For each post, there may be more than one nomination form. The nomination can be a Photostat copy of the specimen or cyclostyled without any Alteration, Addition, Cutting or Overwriting : otherwise the nomination form will be invalid and rejected. Any complaint arising of such rejection may be lodged within the period specified for withdrawal with the State Election Officer, whose decision shall be binding to all and final.

**Note: Always recheck your nomination form before dispatch**

- 3(b) The nomination should be proposed and seconded by bonafied members with the written consent and declarations by the contestant. No proposer or seconder shall have the right to withdraw the name of the contestant so proposed or seconded after the submission of the nomination.
- 3(c) Nomination fee of ₹ 1000/- (Non-refundable and non-transferable). For each nomination, form must be remitted by depositing in AIMLTA, UP State Account No.100654907419, State Bank of India (SBI), IFSC-SBIN0000211, Name: All India Medical Laboratory Technologists Association, U.P. State and its Banks pay-in-slip/Counter foil/Transaction slip in original should be enclosed mandatorily with the nomination form otherwise the nomination form will be rejected.
- 3(d) All nomination form shall be sent by **Registered Post/in person** for one Post and superscribed on the Envelop "**Nomination**" at the Present address of State Election Officer.

**Note:** The State Election Officer will not be responsible for any postal loss in transit of the nomination Form or fee or any other letters regarding nomination etc.

3(e) **WITHDRAWAL** : Any contestant desires of withdrawing his nomination from any post, must so advise in the prescribed proforma (specimen copy enclosed) within the time of withdrawal to the State Election Officer by Registered post / on his own behalf as One can contest for one post only otherwise his candidature will not be considered.

3(f) The candidates are required to report of their presence in the house at the time of election, otherwise in the absentia their candidature will be rejected.

Amendment : If the candidates declared or notified in the final list as unopposed. The contestant shall not be considered as absence at the time of election.

All such unopposed contestant declared invalid due to oversight for absence in the house be declared elected. This was decided by CEC in Maysore (18<sup>th</sup> AIC)

3(g) That in case a candidate has been registered as a delegate on the first day of State Conference or General Body and is absent in the house at the time of election and his absence is on account of unforeseen and unavoidable circumstances beyond his control or due to exigency of services on official grounds, then such absence will not invalidate his candidature, provided further that such absence is communicated in writing to State Election Officer immediately on arising such circumstances which necessitate the absence.

#### **4. POLLING**

4(a) All bonafied representative members, exercising the right of casting vote in the precedence ratio of 1:10 will be require to be present at the specified place in the house at the time of election and will be require to have delegates cards to produce the latest identity slip, issued by the Contestant/State Secretary / CEC Member or other satisfactory proof of identity to the State Election Officer / Pooling Officer. The ballot paper/voting slip will be issued to them only. Other member delegates will sit on back row.

4(b) All bonafied representative members, contestants, proposers should bring the original enrolment membership receipt / renewal receipt or a certificate from State Secretary for confirmation to their bonafidity and produce whenever asked. They must be regular bonafied member at the time of voting.

4(c) Each bonafied representative member shall cast only one vote for each post from the panel of valid nominations.

4(d) Immediately after the election, the casted votes will be counted in the presence of agents deputed by the candidates and the successful candidates will be declared elected in order of number of votes pooled for them. In case of a tie, the decision shall be lots system.

#### **5. DISPUTES**

5(a) Any objection to the election shall be sent to the State Election Officer in the form of an Election Petition, accompanied by a petition fee of Rs. 50/- (to be remitted by money order) and MO receipt enclosed, by registered post, within a fortnight of the announcement of results. The petition must contain a brief statement of the material facts on which the petition relies and be accompanied by a list of evidence which the petitioner wishes to produce to prove his statements and objection.

5(b) The protest note regarding the intention to file the petition should be lodged within 24 hours after the declaration of election results, otherwise the petition will not be admitted.

- 5(c) The election petition shall be adjudged by an Election Tribunal consisting of three members i.e. SEO, Observer and State Executive Uttar Pradesh.
- 5(d) The returned candidate shall be entitled to execute the right & perform duties as duly elected person, till the Election Tribunal declares his/her election null and void.
- 5(e) The decision of the Election Tribunal in his regard shall be final and binding on all and cannot be challenged in any Court of Law.

## 6. PUBLICITY & CANVASSING

- 6(a) The contestant may canvas in their favour at individual level after the announcement of final list by the State Election Officer, but not on the election date & time and in the house, otherwise his candidature will be cancelled.
- 6(b) Loudspeakers, posters, banners, slogans are not allowed for announcement or display as canvassing.

## 7. VACANCY

- 7(a) Mid term vacancy of the State Executive caused due to any reasons, shall be filled up by State Executive at its meeting amongst the State Executive Committee.
- 7(b) In case any post remain unfilled during the election, State Executive Committee can co-opt any bonafied members for the post.
8. The State Election Officer, election sub-committee have all rights reserved for taking necessary decisions, making any additions, changes in rules and regulation and change in programme of election, as and when required.
